Final payment of the remaining balance is due 30 days prior to the "Wedding Date." Walker Media Source will contact the bride or groom (whichever is specified) regarding final details within one week of the wedding. In the event of a cancellation or postponement, the deposits paid are non-refundable. Any non-refundable deposits can be used as a credit for future media services through Walker Media Source for a period of one year. Your final DVD will be ready 10-12 weeks **following the receipt of all photos and music**. Any personal changes that have not been previously agreed upon will be completed at a rate of \$50.00 per hour. Please remember that your wedding DVD includes *highlights* of the day. The ceremony is the only event which is captured from beginning to end without interruption. It is the professional and artistic discretion for Walker Media Source to decide which highlights will be creatively included in your final product. In the event of a wireless audio failure during the vows or ring exchange, a credit of \$150.00 will be refunded to the client. Walker Media Source takes the utmost care with respect to handling raw footage, capturing important events, and delivering the finished product. However, in the event that Walker Media Source fails to comply with the terms of this contract, (i.e. lost, damaged, or stolen tapes/equipment) Walker Media Source's maximum liability shall not exceed the amount paid by the client. Walker Media Source reserves the right to use video footage for display, publication, and other marketing/advertising promotional use.
